



Shared Gifting Shifts the Power Dynamics in Philanthropy

RSF Social Finance's participatory grantmaking program, Shared Gifting, gives full decision-making authority and allocation of funds to community leaders. Since 2011 we have held 14 circles that have engaged over 100 participants, and supported several funders adopt Shared Gifting into their own work.

Transformation

The Shared Gifting program transforms the field of philanthropy by bringing collaboration, trust, transparency, and community wisdom into the grantmaking process to foster the relationships needed to build a compassionate and regenerative economy.

Collaboration

Shared Gifting is an effective and engaging way of disbursing grant funding. By having no predetermined outcomes or objectives for how the recipients use the money, the group uses its collective wisdom to determine the best use of the funds, which frees the recipients to create mutually beneficial collaborations that are not frequently found in typical grantmaking models.



Community

This program's overarching intention is to let the community decide how its community wealth is distributed. The group is accountable to one another and the work they are all collectively doing in the field, rather than being beholden to funders, grant contracts, and measurement tools.

At the University of Minnesota Extension, we have found that participatory grantmaking can help restore trust between marginalized communities and large institutions through its decentralized, democratic processes.
